Author Kenneth Brown Pens Fascinating Memoir, *The System Versus the Law*

(CHERRY HILL, NJ) (28 October 2008)—In his honest and gripping tale, *The System Versus the Law*, Kenneth Brown tells how he battled to prove his innocence after his arrest for two crimes he did not commit. He takes readers on an intimate journey through his mind as he faced incarceration and overcame substance abuse (drug addiction) and a mental breakdown. Eventually winning his freedom from prison, he ends with a hopeful outlook on rebuilding his life and family relationships, focusing on fatherhood and parenting.

Kenneth Brown is the father of three grown daughters, and he is divorced. Born in New York City, he now lives in a suburb of Atlanta, Georgia. He has been deeply influenced by people, such as, Carl Brown, Thurgood Marshall, Malcolm X, Bill Cosby, Bill Clinton, and Gurumayi Chidillasananda. *The System Versus the Law* is Brown's debut book, and he has also written several articles: "Black History," "Fathers," "Message to My People," "Religion," "My Viet Nam," "Emotional Awareness," and "Corrected Vision."
